Our camp has been designed to provide children ages 4-12 the opportunity to participate in a variety of activities and facilitate learning throughout our camps this summer. We have staff that are passionate about their jobs while ensuring a safe yet exciting atmosphere for the children.

Our Day Camp and Mini Camp run from June 17th, 2024 to August 16, 2024. Each week has its own theme and planned activities. Fee & Refund Policy:

The Summer Day Camp fee is \$135 for residents and \$175 for non-residents for the entire week. Payment is due in full at the time of registration. Registration is accepted online at www.plainvillerecdesk.com.

Our camps are very popular and fill up quickly. Our policy canceling a registration needs to be done 2 weeks or more before a program starts and there is a \$10.00 cancelation fee (the convenience fee of the program was paid for by credit card is kept as well). Within 2 weeks, on business days, you can request a refund, but it will only be granted with a cancelation fee if we can fill that registration slot. Once the week of camp has started there will be no refunds.

Enrollment

Enrollment is open to any child aged 4-12 and the child can interact appropriately in a group setting. Enrollment shall be granted without discrimination with regard to gender, race, ethnicity, and religion. Children ages 4 – 6 will be at Paderewski. Children 7 – 12 will be at Norton Park Pavilion.

Week 9: Beach Bash (8/12 - 8/16)

Snack/Lunch

Please send all campers with lunch, snacks, and water (2 bottles) daily, particularly if your camper is a picky eater or has an allergy. **All children sent to camp must bring at least one water bottle.** Please note that there is no opportunity to heat food for campers so please plan accordingly. In addition, Plainville Recreation is now offering a free lunch program. All children that are sent to camp without a lunch will receive free lunch. The lunch program will begin on June 24th and will go to August 9th.

Swimming

Children at Norton Park will swim daily. Children at Paderewski Park will have access to the Splash Pad. Please make sure the kids are ready for a fun day in the sun by providing bathing suits, sunscreen, and towels.

Weather Related Policies and Sunscreen

- Day Camp will be at the local schools (Wheeler School or Toffolon) on days of inclement weather. There will be no pre-care or post-care and camp will run from 9:30am to 3:00pm. Mini Camp will be at the Recreation Department (50 Whiting Street) and will run from 9:15am—3:15pm.

Notifications will go out via e-mail blasts and on our social media. Please provide your child with sunscreen (in a spray form, we will not apply lotion sunscreen on your child) with his/her name on it.

Attire

Campers will be involved in many activities including arts & crafts, running, playing, and water activities. Sneakers are required. Please send a towel and bathing suit daily for water activities. Please label all personal belongings. Plainville Recreation is not responsible for lost, stolen, or damaged items. Any item that is brought to camp that is deemed inappropriate or used in an inappropriate manner, will be held by the Camp Director and returned to the parent/guardian at the end of the day. Please apply sunscreen to your child prior to arriving at camp. Staff are not permitted to apply sunscreen to campers, so please send them with spray sunscreen. Any sunscreen sent to camp must be labeled with your child's name.

Rules and Policies

Rules of Conduct Guidelines are set and followed to ensure the safety of each child, staff member, and the safety of the group; to protect the rights of both the individual and the group; and to provide a positive atmosphere for growth in personal control and responsibility. Our staff will use positive guidance, redirection, setting clear limits, and continuous supervision by staff, during corrective discipline. If a counselor is experiencing behavioral problems with a child, parents will be called. Depending on the severity and frequency of the behavior, the Recreation Department reserves the right to dismiss any child from the program.

- Campers must be able to use the bathroom independently.
- Campers must understand and abide by camp rules and follow directions.
- Campers must participate safely and effectively in a variety of activities.
- Campers must pay attention without being disruptive and understanding consequences of inappropriate behavior.
- Campers must interact with peer groups in a civil manner.
- Campers must follow counselors' instructions and be respectful of staff and peers.
- Camper's must leave valuables at home. Toys, Heely's, and electronic devices are not allowed at camp.

Staff shall not use abusive, neglectful, corporal, humiliating or frightening punishment under any circumstances. No child shall be physically restrained unless it is necessary to protect the safety and health of the child, or others.

1. Individuals will be asked to change inappropriate, disruptive or unsafe behavior.
2. Staff will make every effort to redirect the child's behavior. In order to achieve this Plainville's Day Camp has a three-point system will be in place. At point one, the child will be spoken with about how his/her behavior and ways they can correct it. At point two, the child will be pulled aside again and asked what they think they did wrong and how to correct it. At point three, the child will

be asked to sit out for five minutes from the activity they are doing. Then child will have an opportunity to regain control and discuss the problem with a staff member.

3. Removal of a child from the group for disciplinary or health reasons shall be to a location where visual staff supervision will be maintained.
4. Parents will be asked for their support in changing their child's behavior. Continued inappropriate, unchanged behavior may result in suspension or dismissal from the program. (Refer back to Rules of Conduct).
5. Parents will receive a written notice and spoken with in person about the immediate removal of their child from camp due to unchanged/inappropriate behavior with no refund.
6. Parents should feel free to consult with the Camp Director or the Recreation Coordinator regarding their child's conduct. If necessary, they may also bring the matter to the attention of Director of Recreation for consultation.
7. All violations will be properly documented in the form of a written behavior report. The written behavior report will be reviewed with the parent/guardian and documented in Plainville Recreation files and confidentiality will be maintained at all times.

When continued behavior forms are being filled out for the related incidents (not relating in harassment, violence or threatening behavior), the child may result in a one-day suspension from Plainville's Day Camp.

If a child's behavior results in threatening another child and/or physical contact with another child, staff member or person- an automatic behavior form will be filled out and may result in a suspension that will be determined by Recreation's Office Administration. The suspension may result in more than one day and is at the discretion of the Recreation Coordinator, Assistant Director and Director of Plainville Recreation.

In order to protect the well-being of the children in the program, the Recreation Coordinator, Assistant Director, and Director of Plainville Recreation are authorized to suspend anyone who fails to follow the Rules of Conduct or endangers any of the children in any way. If any child or family member is unable to function cooperatively within the framework of the program, Plainville's Day Camp reserves the right to terminate the child's registration.

Child Custody Policy

In the event of a divorce or parental separation, Day Camp will abide by the Authorized Pick-Up List provided by the parent who registered for the program. Parents unable to abide by this regulation will be requested, in writing, to withdraw their child immediately. *Parent/Guardian, please make sure to include yourself on the pick-up list.*

Swimming

Plainville Recreation Day Camp will swim periodically throughout the week each session. Kids that are signed up for 2 consecutive weeks will be given the opportunity to take swim lessons. You must provide a note if you do not want your child to partake in swim lessons. Swim time will occur late mornings and early afternoons. Please remember to pack a change of clothes. A bathing suit, and towel.

Arrival, Pick-Up and Other Program Information

Drop for Day Camp will be at Norton Park Pavilion. Drop of for Mini Camp will be at the Band Shell Pavilion. Please bring a photo ID every day for pick up. Only authorized individuals on the pickup list with a photo ID will be allowed to take the child. Please be PROMPT for pick up. Please note if a child is not picked up after a reasonable amount of time, the Plainville Police Department will become involved. If you need to reach a staff member, please call the Recreation Department at 860-747-6022.

Illness or Injury

If your child is sick, please keep them home. Please report any communicable diseases promptly, i.e. COVID19, Chicken Pox, Head Lice, Pink Eye, etc. to the Camp Director (refunds or credits are not given for missed camp days). If your child tests positive for COVID-19, please call the Recreation Department at 860-747-6022. Children who are injured at our camp will receive the appropriate first aid. Staff members will fill out a first-aid form and report the incident to the Parent/Guardian. If there is a medical emergency, staff members are authorized to call 911.

Medications

Only the camp director and assistant director can administer medication. All medications are kept in a lockbox. All staff can remind children to take medication and supervise self-administration. All medication must be presented in their original prescription containers. All inhalers and epi-pens must have a medication form.

Cell-Phone Policy

Plainville Recreation Summer camps take great pride in the offering a high quality camp experience to each of our participants. While understanding the roles cell phones and other electronics play in today's society, their usage in the camp environment has proven to be distractive and disruptive to the camp day. That being said, we are asking parents/guardians to not have your child bring their cell-phones unless it's for a medical reason or excused by the Recreation Coordinator.

Once approved, campers must leave their cell phones within their bags/ backpacks. They should not be out or visible during these periods.

- o Additionally, phones should not be in their pockets as it may compromise their ability to participate in select activities.

Camp Leaders

Each year, all of the Plainville Recreation Staff take part in a variety of trainings to ensure they are ready for the summer. Our staff includes camp counselors, a camp assistant director, and a camp director. Plainville Recreation Day Camp has 1 camp director and 1 assistant camp director. Our Mini Camp has 1 camp director. Please reach out to the camp directors at any point if you have any questions or concerns.
